- 1) Sealed Tenders are invited from bonafied /indigenous /overseas manufacturer and /or their authorized representative on turnkey basis, for 90 KLPD Ethanol Plant.
- 2) Qualification Requirements:

The Bidders should be manufacturer and should be in the line of business of manufacturing in the same field for the last Ten years and **Net Worth should be Positive.**

 - a) Company turn over should be minimum 100 crore for last 3 years.
 - b) The bidders should have designed, engineered, supplied, erected and commissioned a minimum of ten (10) Distillery plants out of which five should be 60 KLPD and above. Three plants should be supplied overseas and should be in operation for a minimum period of one (1) season/s.
 - c) Bidders should have supplied 3 CPU plants and 3 spent wash evaporators stations.
